Advice to Insurers

Insurance companies also exhibit shortcomings, in the absence of a specialist team which would be able to prevent them from committing frequent errors and omissions in the placement of risks through reinsurance intermediaries, who often fail to verify certain aspects such as the adaptation of the reinsurance terms to those in the original policy or that both policies are consistent, compliance with the conditions of the reinsurer, operation of the control clause and, in general, all aspects inherent to the management and maintenance of dialogue with reinsurance companies when losses occur in which the insured may potentially be covered.

Most cedants are generally moving away from accepted customs and practices, which mean that when they indemnify their insured, do not receive the prompt reimbursement from reinsurers which the latter are obliged to provide. This situation always translates into a **waste of time, money, effort and leads to the breakdown of the commercial relationship** between the parties involved.

In order to avoid this situation, we **advise** insurance companies on all aspects of the placement of risks and **support** them in the management of claims, so as to **ensure** that they recover the indemnity paid to their insured promptly, efficiently, effectively and in accordance with the terms agreed.
